



RELEASE AND HOLD HARMLESS/AGREEMENT

In consideration of my admission to K-9 training classes, participation in phone consultations and/or in-home/private/on-site training, I the rightful owner hereby release Central Florida K-9, National Canine Training LLC and its agents/consultants from any actions, claims, or demands from any personal injury to myself my dog, and or property damage which may arise out of my participation in dog training classes, phone consultations, and/or in-home/private training sessions/classes/Contract work. The safety of the student's dog, and individuals the dog has contact with (during and after training), is the sole responsibility of the student and not the trainer(s). The student/owner assumes all risk to themselves, their children, their guest(s), their dog, and their property. The student/owner understands that children under the age of 12 will be allowed to attend group classes but must be supervised at all times. The student/owner will indemnify and hold harmless Central Florida K-9, owners, consultants, employees, agents and property owners in which training is being conducted, against any physical harm or property loss/damage during and after training. The student also agrees to pay for any cost(s) associated with property damage and/or injuries caused by their K-9 while attending training at Central Florida K-9. *The trainers/consultants, Central Florida K-9, Owners and its agents do not accept responsibility for the lack of progress in the dogs' training, as there are too many variables in the home environment beyond the trainers' control.*

Cancellations and refunds:

If your dog is ill, injured, or in heat, they should not attend class and the student can reschedule. Refunds are not given within 7 days of the start of class. Refunds are also not given for in-home training/private sessions/board and train/evaluation appointments where a *minimum of 48 hours cancellation via phone was not given to the Training Manager*. The trainers/consultants, Central Florida K-9, Owners and its agents are not obligated to give private sessions, in-home training, or behavior consultations for missed class. If it is determined by the trainer(s), Central Florida K-9, Owners, and or its agents that your dog is not able to attend group classes due to behavioral problems (excessive barking, biting, aggression toward humans or other dogs) or health problems, the handler may schedule private/in-home classes and apply any pre-paid funds toward the cost of private/in-home problem-solving training, board and train, but a refund will not be given. If the handler chooses to remove their dog from private classes for any reason, the handler may audit the remaining classes without their dog, but a refund will not be issued. The trainer(s), Central Florida K-9, Owners and its agents reserve the right to remove a student and dog from class and/or boarding if they deem necessary. Partial or full refunds will be determined by the training manager.



Training/Boarding Agreement: \$95.00 - \$145.00 a day.

No matter how well trained a dog is, they may still act unpredictable in new or threatening situations. Children should never be left unsupervised with a dog. While in public, dogs must be under the control of a leash and/or an e-collar. The dog should be current on all vaccinations, with Bordetella received within the last 6 months. Additionally, we recommend that your pet have microchip or tattoo identification.

The Hold Harmless Agreement shall remain in effect for the duration of the dog's life. I give permission to Central Florida K-9, its owners, and agents, to discuss and or treat my dog for injuries and behavior issues while at CFK9. I also give permission for CFK9/agents to transport and discuss, if necessary, my dog's behavior and/or health problem(s) with my Veterinarian or the CFK9 approved Veterinarian and their staff. I will also be responsible for all costs associated with such visit as well as a transport fee of (\$40.00).

Boarding: \$40.00 a night: In consideration of my admission to boarding, I release Central Florida K-9, National Canine Training / DBA Central Florida K-9 and its agents / consultants / employees from any actions, claims, or demands from any personal injury to my dog/others and understand and agree to pay for any cost associated with property damage and / or injuries (dog or human) caused by my dog while boarding at Central Florida K-9.

Attorney's Fees. In the event any litigation, mediation, arbitration, or controversy between the parties hereto arises out of or relates to this Agreement, the prevailing party in such litigation, mediation, arbitration or controversy shall be entitled to recover from the other all reasonable attorneys' fees, expenses and suit cost, including attorneys' fees, expenses and suit cost associated with any appellate proceedings and any post-judgment collection proceedings.
